

KORUS FTA Safeguard Status Report as of 8/5/2024

The following table provides information on the fill rate of products subject to agricultural safeguards (ASG) under the KORUS FTA. The column headed “Medium Stage (Products with intermediate safeguard)” describes the fill rate for ASG for products that have intermediate safeguard trigger levels, such as beans, sweet potatoes, popcorns, etc. The second column headed “Final Stage (Products with main safeguard)” describes the fill rate for ASG for products that have main safeguard trigger levels, such as beef, pork, onions, etc. Please note that when products subject to "intermediate safeguard" are imported, the same amount will also be counted against the the "main safeguard" fill rate. Once the fill rate goes over 100 percent, the imports will be subject to the safeguard duties under the KORUS FTA. The columns headed, “Fill rate (%), based on customs clearance” are based on actual entry of the products through Korean Customs. This information is supplied by the Korean Customs Service.
